ORDINANCE 2006-01

ORDINANCE FOR DESIGNATED ATV ROUTES

The Town Board of the Township of Orange, Juneau County, Wisconsin, does ordain as follows:

Section 1

ATV ROUTES DESIGNATED- following all rules as provided in Section 23.33 and all subsections of the Wisconsin State Statute- hereinafter designate the following roads to be designated as ATV Routes. Township roads authorize as ATV routes:

1. Orange Mill Rd from CTY H to Hwy 12&16. (crossing Hwy 12 & 16 to trail)
2. Jensen Rd from Hwy 12&16 to 6th Ave.
3. 6th Ave. from Jensen Rd to CTY C.
4. 6th Ave. from CTY C to River Rd.
5. River Rd from 6th AVE. to Cutler/Orange township line.
6. 34th ST. from 6th AVE./River Rd to 5th AVE.
7. 5th Ave from 34th ST. to River Rd.
8. 29th St. from 2nd AVE. to 1st AVE.
9. 2nd Ave. from 29th St. to Cutler/Orange township line.
10. 28th St. from Cutler/Orange township line to Clearfield/Orange township line.

Local Access Road Only

1. Orange Mill Rd from CTY H to Camp Hill Rd.
2. Camp Hill Rd from Schucht Rd to Camp Douglas Village/Orange town line.
3. 37th St. from 6th AVE. to 7th AVE.
4. 7th Ave from 37th ST. to Clearfield/Orange township line.
5. 34th St. from CTY M to 6th AVE./River Rd.
6. 30th St. from CTY M to Clearfield/Orange township line.
7. 30th St. from CTY H to River Rd.
8. 29th St. from CTY H to 2nd AVE.
9. Schucht Rd from Camp Hill Rd. to Fountain/Orange township line.
10. Jenson Rd. from 6th AVE. to Fountain/Orange township line.

Section 2

OTHER RULES THAT APPLY TO THIS ORDINANCE

1. Must obey all laws and new laws that are set by the Department of Natural Resources (DNR).
2. Maximum speed on all routes is 25 mph, or less as posted.
3. No one under 18 years old riding after 9:00 pm curfew, unless accompanied by parent or legal guardian.

4. No one under 12 years old may operate on ATV routes, as stated in DNR rules.
5. At all times stay on the roadway in single file unless safety deems it necessary to momentarily use any right of way for travel.
6. All other licensed vehicles and pedestrians shall have the right of way.
7. No damaging of any part of roadway or right of way while operating an ATV on any part of the designated routes.
8. Operation of ATV's in the township of Orange only on designed routes. All laws for other operation are covered in 23.33 of the Wisconsin State Statutes and all subsections for off trail operations.
9. All ATV's while in operation on the routes will have lights on at all times.
10. Each year on the Nine day gun/deer season, all ATV routes will be closed.
11. ATV Club will be providing and inspections of routes and will notify the Township Board of any possible hazards. Also will be responsible for the inspection of safety signs put up to designate the routes.
12. Designated routes in the Township of Orange are to be renewed on a year to year basis.
 - In October of each year the club is required to attend the regular town board meeting to request the ATV trail renewal and at that time requests can be made for any amendments or deletions to the designated route. ATV routes are then renewed at the November regular town board meeting.

Section 3

PENALTY- Any person who shall violate any provision of this ordinance shall upon conviction thereof forfeit not less than \$50.00, nor more than \$500.00; together with the costs of prosecution and in default of payment thereof may be imprisoned in the county jail not exceeding 90 days.

Section 4

FORFEITED PENALTIES AND DEPOSITS- Except as otherwise provided in the Wisconsin Statutes and the deposit schedule adopted by the state board of circuit judges thereunder, the forfeited penalties and deposits or bail not including costs or fees for violations of this ordinance, shall be equal to or less than the sum of \$250.00.

Section 5

ORDINANCE TO BE FILED- The clerk shall file a copy of this ordinance upon its enactment and publication with the Wisconsin Department of Natural Resources, and with the sheriff of Juneau county.

Section 6

This Ordinance shall be in full force and effect from and after its passage and publication.
